After weighing their priorities carefully, they decided to pass on our offer for the Lead Minister position.

After much discussion and time in prayer, we concluded John was a strong second candidate. We made him an offer.

Given the challenges with finding adequate housing when relocating to a new state, the Weilers made a thoughtful and generous offer to the Gunters. They offered their rental property below market rate in the Lindbergh School District for 12 months as part of the transition. However, it's understandable that other factors came into play during the negotiations, and despite good intentions, sometimes things don't align.

After negotiations were completed, a text message from John Gunter showed a lot of grace and respect. He expressed appreciation for the opportunity and the relationships he and Katie developed during the process, even though the outcome wasn't what everyone had hoped for.

It's always tough when negotiations don't lead to the desired outcomes, but the positive tones in the follow-up messages indicated the Mundies and Gunters appreciated the connections that were made even if ultimately we could not come to an agreement.

As we take next steps in the search process, we are confident God is guiding this process and we will ultimately land where He's leading.
